- h. "non profit public service" – means the service of Trustee to the Trust board without any profit except remuneration and other expenses as mentioned in the Trust Deed.
- i. "Legitimate dues invested by the Trustee" – means and includes the investment of capital in the Trust Board and the interest accrues thereof by any or all the Trustees except the Settlor.
- j. "Liability of Trustee" – means and includes joint and several liability of all the Trustees including personal liability in his/ her/their individual capacity and as well as karta of their respective Joint Hindu mitraskhara Family for payment of dues against Dadhichi Educational Trust to any Bank or financial institution. 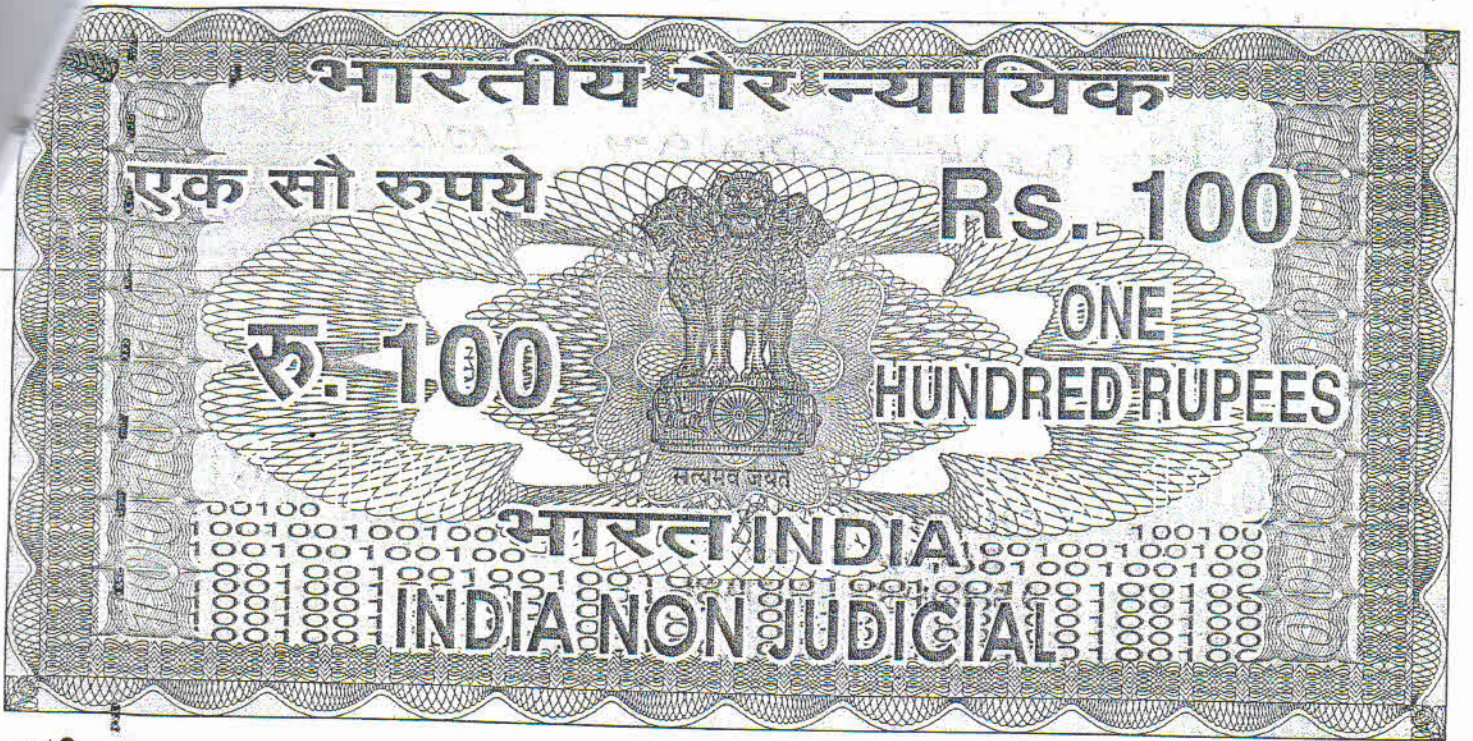

- maintain such building and to do all acts and deeds which may be expedient or necessary for the said purpose;
4. Co-operative or collaborate with other institutions, funds or trusts with objects similar to those of the Trust;
 5. Takeover or to join hands and managed other Trust, institution etc with objects similar to those and the trust.
 6. In the event of any of the first or subsequent trustees ceasing to be a trustee by reasons of death, resignation or any other reasons, the Board of trustees have every right to appoint new trustees and to allocate areas of operation for him/her.
 7. In the event of any of the trustees undertaking activities which are not in consonance with the objectives of the trust and/or is illegal, immoral in eyes of the law, the board of trustees has the power to remove him from the office of the trustees.
 8. Should at any time the trustees fail to agree in the matter of appointment of trustees, the matter shall be referred to the court of the District judge whose selection shall be final and binding.
